Pursuant to Article 44, point 2 and Annex 3B of the Law on Public Procurement ("Official Gazette of RS ", No 124/2012, 14/2015 and 68/2015) hereby announces

**A PUBLIC INVITATION**

**For the collection of bids in an open procedure for the public procurement serial number 81/16**

1. Subject of public procurement for services of a repair and maintenance of medical and precise equipment, OPH 50400000 required for military healthcare institutions of MoD, for, for 2016/2017/2018, in an open procedure with the aim at concluding framework agreements for the period of two years- formed into 145 parties.
2. All interested persons, domestic or foreign legal or natural persons who meet the conditions under Article 75 and Article 76 of the Law on Public procurement ("The Official Gazette of RS", No124/2012, 4/2015 and 68/2015 ) have right to participate in. A bidder is bound to submit with a bid proofs on meeting the conditions.
3. Collection of tender documentation can be done within 30 days from the day of invitation announcement at the Portal of Public Procurement Department, at the MMA premises, 17 Crnotravska Street, Maintenance Unit, III floor, office No 30 every working day from 9 am to 3 pm. Collection of tender documentation can be done by an authorized person of a bidder having the authorization in writing. The tender documentation is available on website of MoD [www.nabavke.mod.gov.rs](http://www.nabavke.mod.gov.rs) and Portal of Public Procurement Department.
4. The bids with documentation according to the instruction in tender documentation are submitted in a closed and sealed envelope/box, with the label „services for the repair and maintenance of medical and precise equipment“, party \_\_\_\_\_ **number DV 81/16 – DO NOT OPEN**", at the address: Military Medical Academy, 17 Crnotravska Street, Maintenance Unit, III floor, sending them or delivering them in person at the desk office of the MMA, every working day (Monday-Friday) from 8 am to 3 pm.
5. Deadline for delivering bids is at least **35 days** since the announcement of invitation at the Portal of Public Procurement of RS to 8.30am no matter of the manner of delivering the bids.
6. Public opening of bids will be done at **09:00am** the same day when the deadline for submission expires i.e. **25.04.2016** at: Military Medical Academy, Belgrade, 17 Crnotravska Street, Scientific-Teaching Hall, III floor. The authorized representatives of bidders can attend, who should prior to bid opening procedure submit their authorization to the commission.
7. Untimely bids shall not be considered and shall be returned unopened to a bidder.
8. The decision on the award of framework agreements shall be done within 25 days from the day of opening of bids.
9. Framework agreements shall be concluded with all bidders who meet the mandatory and additional conditions stipulated by the tender documentation.
