1. **Name of ordering party:** Fund for Social Insurance of Military Insured.

7. **Description of goods, name and reference from the general procurement dictionary:** JN No. 1/16– Drugs for human use - pharmaceutical products- 33600000.
8. **Number of batch:** procurement is comprised of 914 batches.
9. **Criteria for contract award:** Decision on contract award will be made after respecting the criteria „the lowest offered price”.

**Deadline date:** April 12, 2016, until 10.00 a.m.

12. **Place, time and method of offers opening:** Public opening event will be made within the premises of ordering party, i.e.: Fund for Social Insurance of Military Insured, 13, Krunska St., 11000 Belgrade, ground floor – room 8.  
Offers will be assessed immediately as a deadline date has expired, namely April 12, 2016, at 10.15 a.m.  
Opening of offers is transparent and all interested may present.

**13. Conditions for suppliers to present at the opening event:** The opening process may be actively attended only by authorized suppliers. Prior to this event, the representatives of suppliers are responsible to submit written request for participation at the offers opening addressed to the Public Procurement Commission, specified by the name of the person who attends the opening event, approved and signed by legal bidder representative. In case this procedure is not respected, they participate as a public and cannot take steps within the opening process.

**14. Deadline for assessment:** Contract will be awarded in the period from 40 days since the day the offers are opened.
