**Type of public procurement procedure**

The present public procurement is conducted in an open procedure in order to conclude agreements for a period of two years, according to the Public Procurement Law and other regulations.

**The subject of procurement**

The subject of procurement number 16/2017 (666/2016), are goods - Diagnostic material analyzers Siemens, Roche and Abbott for military medical purposes MoD and SAF in 2017 and 2018, defined in 16 lots.

Participation is open to all interested domestic and foreign legal entities and natural persons who fulfill the requirements of Article 75 and Article 76 of the Law. The bidder is obliged to submit evidence of fulfillment with the bid of requirements.

### Tender documentation

The tender documentation is published on the Portal of the Public Procurement and the website of the Ministry of Defence [www.nabavke.mod.gov.rs](http://www.nabavke.mod.gov.rs).

Tender documents are available at the premises of the Military Medical Academy, 17 Crnotravska Street, in the Department of Supply SLo, every working day from 9 to 15 hours. Only authorized person with the written authorization can take over tender documents.

### The manner and place of tender submission

Tender is to be submitted to the following address: Military Medical Academy, 17 Crnotravska Street, Belgrade, stating: „Tender for the supplying goods number 16/2017 - DO NOT OPEN ”  
The envelope is necessary to contain: the full name of a bidder with the address, phone number and name of contact person. Any tender received after the deadline will not be considered.

The deadline for submission of tenders is till 9.45 am, 13 April, 2017.

Public opening of tenders will be open by the Commission for public procurement, the last day of the deadline for submission of tenders, starting at 10 am at the address: VMA, Beograd, 17 Crnotravska street, fifth floor, room 40b.

Before the start of tender opening the Tenderers are required to submit a power of attorney for participation in the tender opening procedure to the Public Procurement Commission. The power of attorney is to be submitted in writing and must be filed on tender side, sealed and signed by the authorized person of the tender.

### Type criteria, criteria elements

Criteria for evaluation of offers is "the lowest bid" for each lot.

If two or more tenderers have the same offered price, the most convenient would be the one who offer shorter delivery time. If two or more tenderers have the same offered price and time of delivery, the most convenient would be the one who offer a longer offer option.
